Dear Chairman Bennett and Honorable members of the House Committee on the Environment & Natural Resouces:

Volunteer Services for Animals (VSA) writes to express opposition to H7562 which we believe will give RIDEM the added ability to make decisions that will result in being able to kill river otters. We believe that this legislation is a resurfacing of the otter issue and a similar bill harmful to the river otters that failed in 2014.

VSA testified in opposition to that failed bill in 2014 and continues to strongly oppose legislation that puts the river otters at risk.

Traps such as the steel jaw leghold trap will be one of the means used to kill otters by drowning them. No explanation or reasons have been given to the public to explain the need for this change. Do we really want to return to the days of the commonplace use of the steel jaw leghold trap which

can still be used by obtaining a special permit from RIDEM?

Please don't harm Rhode Island's wildlife by passing H7562.
