RE: Bills S2330 & H7033

Most Honorable Senators and Representatives,

My name is Dr. Robert C. Campbell. I am a Chiropractic neurologist, and herniated disc specialist who has now practiced in Westerly for 29 years. I am asking you for your support and passage of bills S2330 and H7033 which would allow for the inclusion of Chiropractic care in our State's Medicaid program.
