RE: Letter Regarding House Bill 7256 – An Act Relating to Taxation – Sales and Use Taxes – Liability and Computation

## Dear Chair Abney:

I am writing on behalf of the Rhode Island Department of Revenue, Division of Taxation ("Division"), to: i) express concerns regarding issues with proposed House Bill 7256 as currently drafted; ii) explain the background and current statutory context in order to clarify the intended and unintended consequences of this bill; and iii) make recommendations and request your support in implementing those recommendations.

This letter is not intended as a position in support of or opposition to the bill, but only as recommendations on drafting to provide clarity in the bill and to aid tax administration and compliance.

As you know, this bill would amend R.I. Gen. Laws § 44-18-30, entitled "Gross receipts exempt from sales and use taxes," to add to the list of sales and use tax exemptions machinery and equipment used to provide broadband communications service.

The Division is concerned that the bill's wording is overly broad and may result in unintended consequences from such an extensive exemption. Additionally, the proposed exemption would make it difficult for retailers to code products properly and would create an inequitable market for retailers selling these types of items versus a retailer that exclusively sells broadband services and equipment.

Additionally, the State of Rhode Island Division of Taxation is a signatory to the Streamlined Sales and Use Tax Agreement ("SSUTA") pursuant to R.I. Gen. Laws § 44-18.1-1. The SSUTA mandates that a member state must comply with its numerous terms, including notification requirements. As such, the Division recommends an effective date of October 1, 2024, to allow

for reasonable notice under the SSUTA and to ensure proper implementation of the change for all stakeholders.

The Division takes no position with respect to the remainder of the proposed legislation. Rather, the Division is concerned solely with the issues of clarity, tax compliance, and tax administration. As such, the Division respectfully suggests that the bill be redrafted for clarity.

I look forward to working with you to address the issues raised in this letter and appreciate your consideration.
