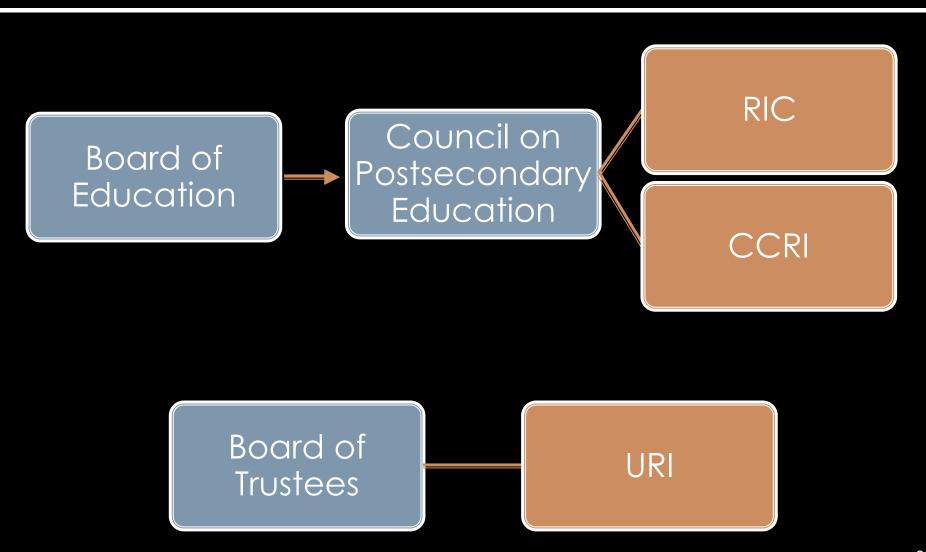

- \$1,594.1 million operating budget
  - 11.2% of state budget
  - 5.7% of general revenue budget
- 4,417.3 FTE positions
  - 27.9% of state total
- \$1,833.4 million capital budget
  - Majority of state's physical property

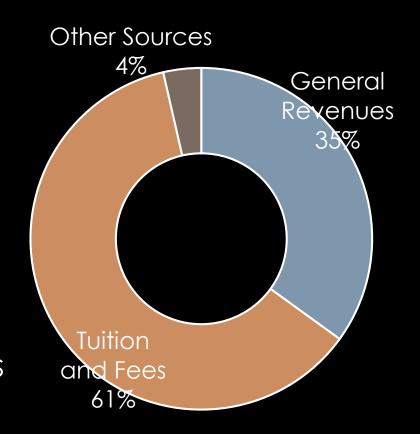

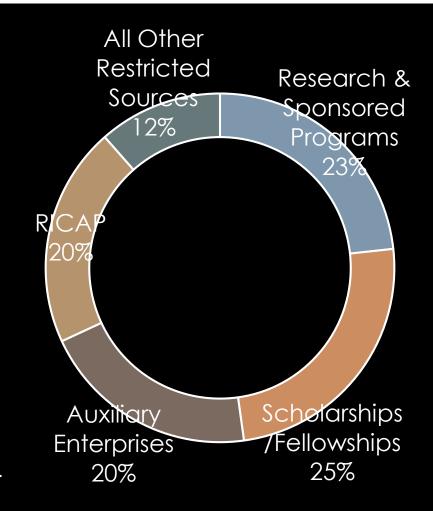
### **Unrestricted Budget**

- Funds used for any legitimate purpose: education & general operations
  - General revenues
  - Tuition & fees
  - Auxiliary indirect costs
  - Like general revenue budget of other agencies
- 59% of FY 2026 budget



### Restricted Budget

- Funds considered restricted receipt or enterprise funds
  - Residence hall & dining funds
  - Other fund sources that are limited to use for certain purposes
  - Federal funds & RICAP
- 41% of FY 2026 recommended budget

  - Research and development
  - Student aid
    - Pell grants
    - Other needbased grants (SEOG)
    - Work Study
    - Loans

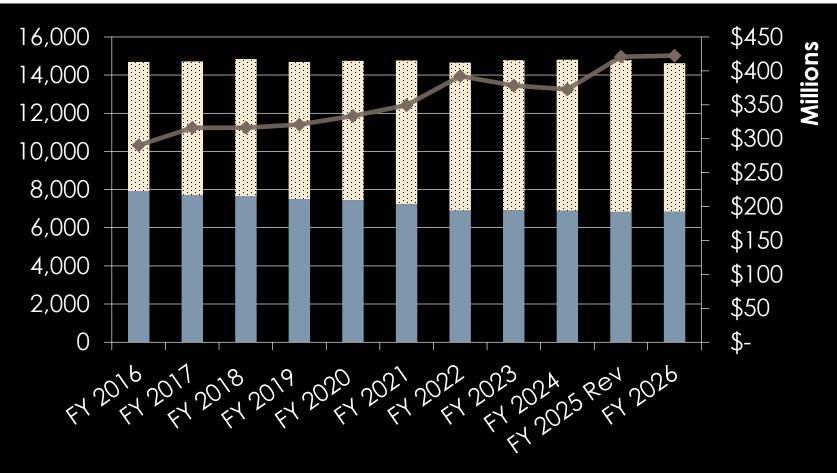

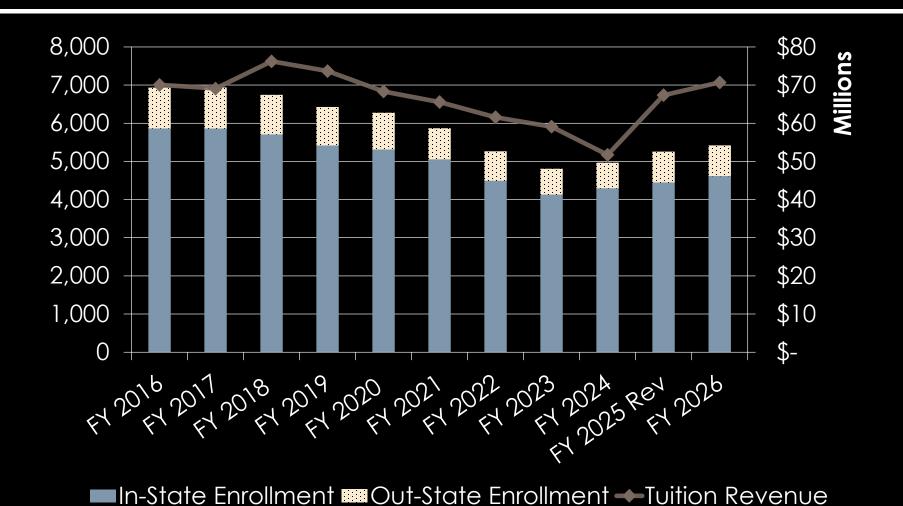

### **URI Enrollment/Tuition Revenue**

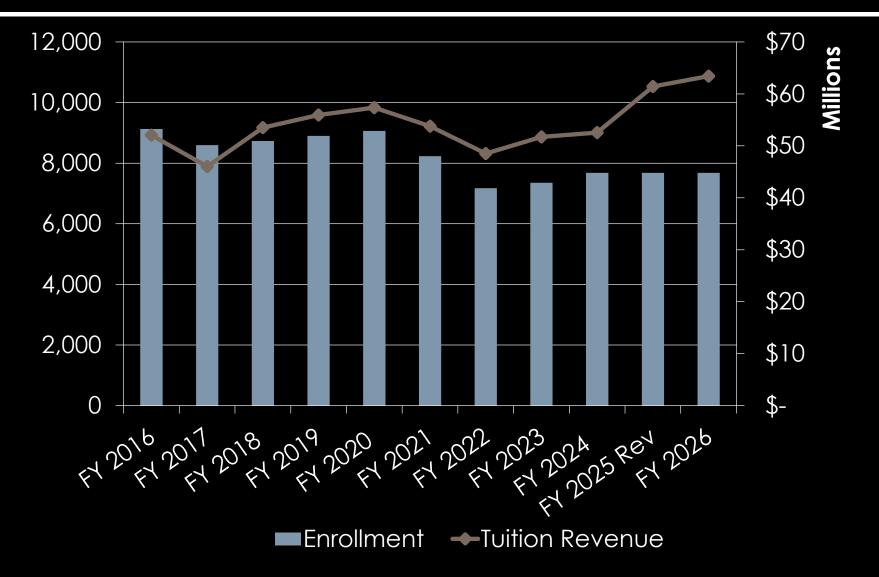


■In-State Enrollment ■Out-State Enrollment ◆Tuition Revenue

### **Approved Tuition & Fees**

- Council approved RIC/CCRI
  - FY 2026 rates approved in October 2024
    - 3.5% tuition/\$67 fee increase at RIC
    - 5.7% tuition/\$18 fee increase for in-state at CCRI
- Board of Trustees approved URI
  - Voted in 2023 to shift final approval to Feb.
    - Approved baseline increase of 3.0%
  - Final approval in February
    - 3.5% increase in tuition/\$16 fee increase

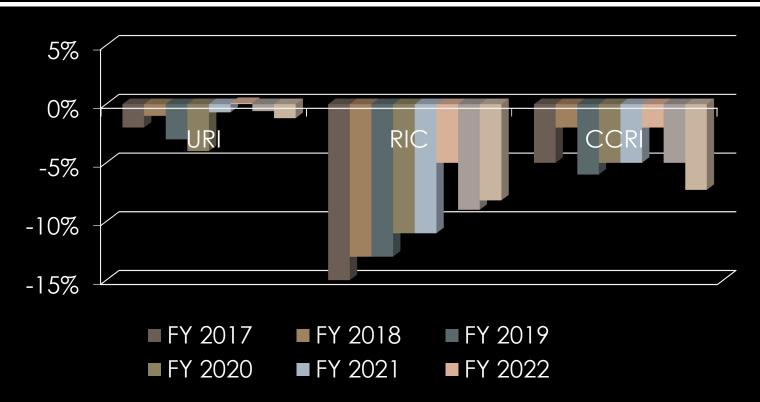

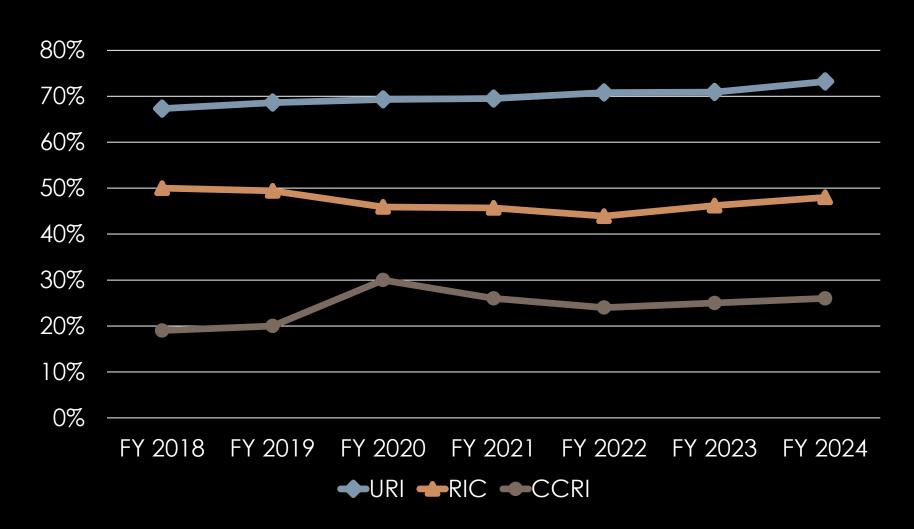

### **OPC Staffing**

- Research-Related Positions (12 FTE)
  - Requests FTE but no funding
    - To hire support if third-party grants are awarded
  - Not recommended by the Governor
- Assistant Commissioner cost allocation
  - Council re-established full-time labor relations function & expanded role
    - Position advises Council, CCRI & RIC Presidents
      - Human resources & labor relations
  - 75% or \$0.2M shifted to two institutions
    - 25% remains in OPC's budget with FTE

### Longitudinal Data System

- Request: \$1.2 million & 7.0 FTE
  - \$0.6 million from general revenues
- Person-level data from early childhood through postsecondary ed & workforce
  - FY 2024 budget codified governance & operations in OPC
- Governor adds \$0.6 million and 2.0 FTE
  - \$0.1 million for current service adjustments
  - \$0.5M; \$0.2M from general revenues
    - Establishes "DATA RI" plus current service

- Article 3, Sections 23 & 24
  - Establishes RI Integrated Data System "DATA RI" as the central repository of inter-agency, longitudinal, linked, & individual data
  - Goals
    - Connect data across sectors
    - Support research aligned with state priorities
    - Inform policymaking & program evaluation
    - Improve well-being of all Rhode Islanders

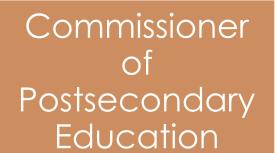

Rhode Island Integrated Data System

- Data RI allows for data sharing
  - Programs retain control of their data
- Central repository of state's data
- Overseen by a single board
  - Approve policies on data requests & information sharing
  - Improves transparency & public accessibility of data

- Governor's budget 6 new FTE
  - 2 for Office of Postsecondary Commissioner
    - \$0.3 million from longitudinal data system sources
    - \$0.2 million from general revenues
      - Data system software
  - 2 for DOA's Division of Enterprise Technology Strategy & Services (ETSS)
    - \$0.4M internal service funds
      - Billings to other agencies
  - 2 for EOHHS
    - \$0.4M 25/75 state-federal match

### Higher Ed Affordability

- Enacted budget \$0.1 million from GR for contracted research services
  - Examine affordability of higher education
  - Provide recommendations on expanding state-funded scholarship programs
  - Begin to develop predictable funding policy
  - Examine strategies for public/private investment
- Governor maintains funding for FY 2025 and FY 2026

### RI Promise – Current Program

- 2017 Assembly authorized Promise at CCRI
  - 2 years of free tuition & mandatory fees at CCRI for qualifying Rhode Island students
  - "Last dollar scholarship" model
    - After a student exhausts all other aid sources the program covers remainder of tuition bill
    - Other non-mandatory fees not covered
  - Recipients are required to
    - Maintain a 2.5 grade point average
    - Commit to remaining in RI after graduation
    - Remain on track to graduate

### RI Promise – Current Program

- 4 cohorts of students starting in fall 2017
- Last cohort was originally those entering in fall 2020
- 2021 Assembly made program permanent

### Hope Scholarship

- 2023 Assembly enacted new scholarship at RIC
  - For students during their 3<sup>rd</sup> & 4th years
    - Originally for 2024, 2025, & 2026 HS graduates
  - Eligibility
    - First time, in-state student
    - Meet minimum GPA requirements
    - Have sufficient credits towards major by end of sophomore year
      - To assure they can stay on track to graduate
    - Not received a Promise award

### **Hope Scholarship**

- 2024 Assembly concurred with Governor's request to extend program to include the last cohort entering in the fall of 2029
  - To allow for better program evaluation
- Also modified reporting requirements to be like those for the Promise program

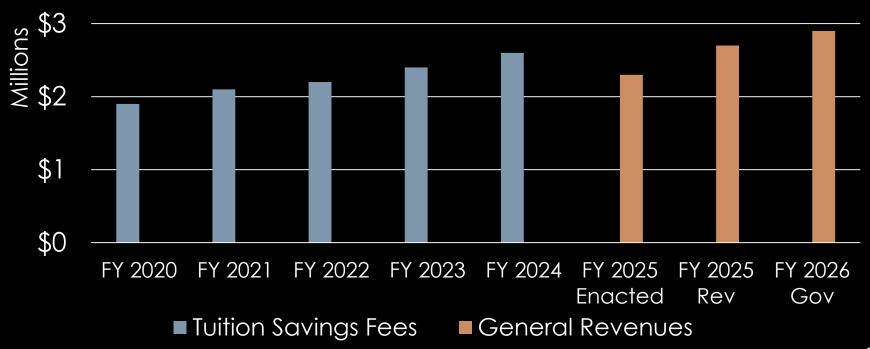

## Dual Enrollment Program

- Allows qualified high schoolers to earn college credit at no cost
  - Students can take courses in two ways
    - Concurrent enrollment courses taken at student's high school for college credit
    - Dual enrollment courses taken at postsecondary institution's campus
- \$2.7M from general revenues for FY 2025
  - \$0.4 million more than enacted
  - FY 2024 overspent by \$0.3M
- \$2.9M for FY 2026

# 2025-H 5075, Article 1, Sec. 8 & 2025-H 5076, Article 1, Sec. 20

- Dual Enrollment allows high school students to earn college credit at no cost to the students
  - New regulations took effect in FY 2019
    - Lack of enrollment oversight & overspending during FY 2017



# 2025-H 5075, Article 1, Sec. 8 & 2025-H 5076, Article 1, Sec. 20

- Transfer to state general revenues from the Rhode Island Student Loan Authority
  - Scoop is linked to support for Dual and Concurrent Enrollment program
    - Equal to amount of general revenue spending

## Last Dollar Scholarship

- Helps students already receiving financial aid with additional costs
- Governor recommends \$9.9 million
  - \$6.5 million from general revenues
  - \$3.4 million from tuition savings fees
    - General revenues have been covering decline in tuition savings fees
- Funding to all three public institutions
  - Lesser of 20% or \$1.8 million to nonprofit private higher education institutions
    - Increased from \$1.5M in FY 2024

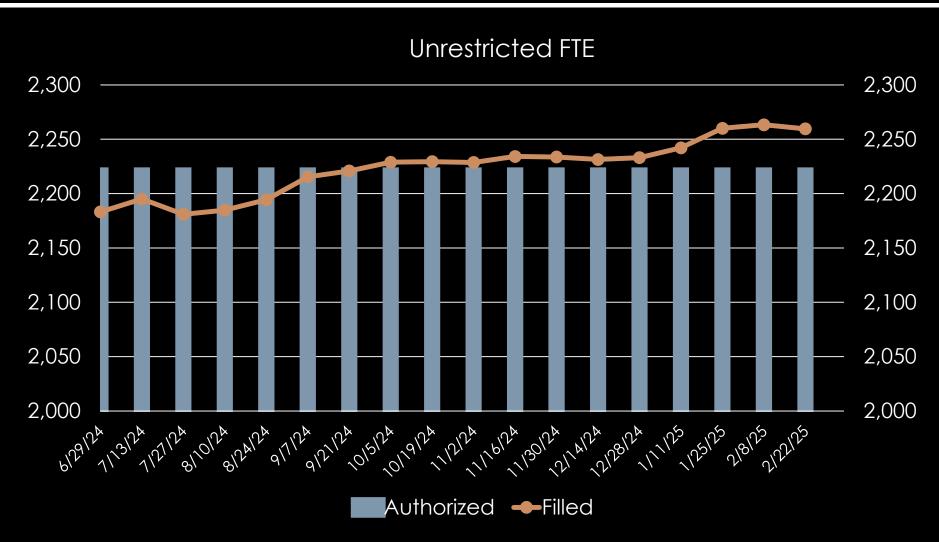

### FY 2026 Recommendation

- Gov recommends current service budget
- Article 1 has proviso language allotting money to "support programming related to career readiness, career placement, internships, and work-based learning"
  - Intended to highlight work already happening
    - Does not necessarily require additional investment
  - \$874,069 for URI
  - **\$464,377** for RIC
  - \$391,175 for CCRI

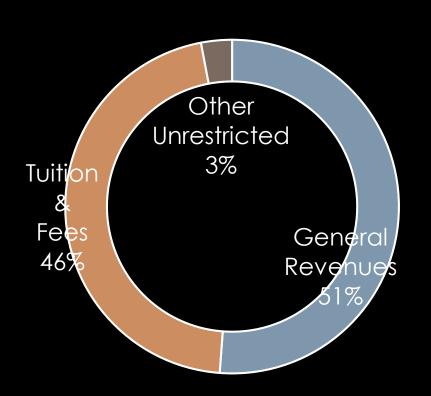

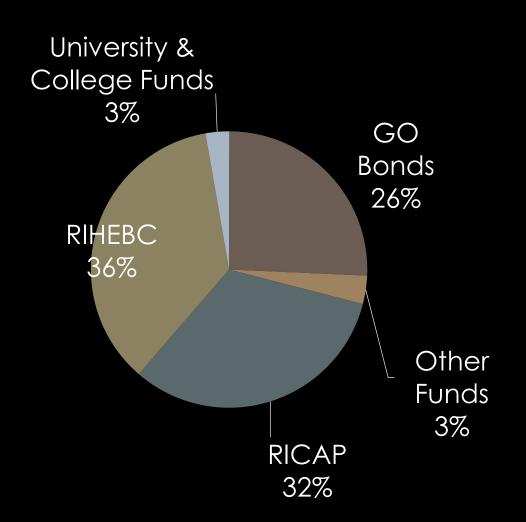

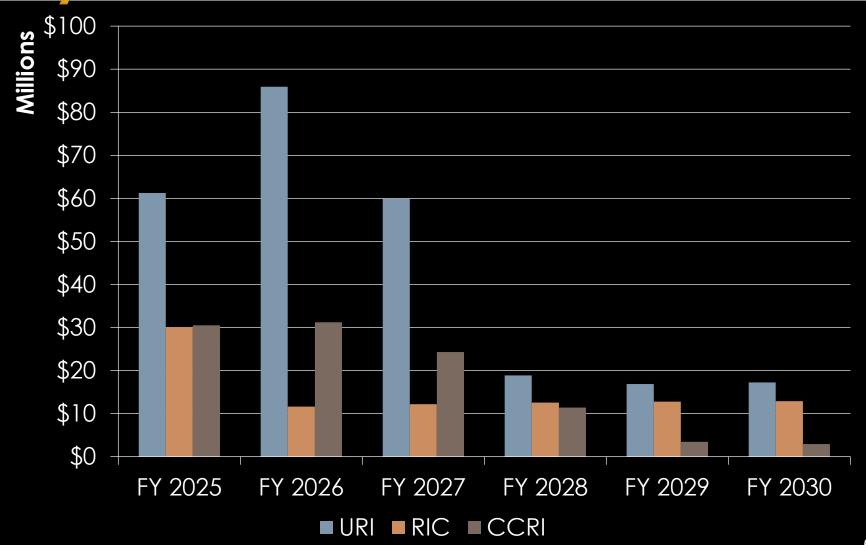

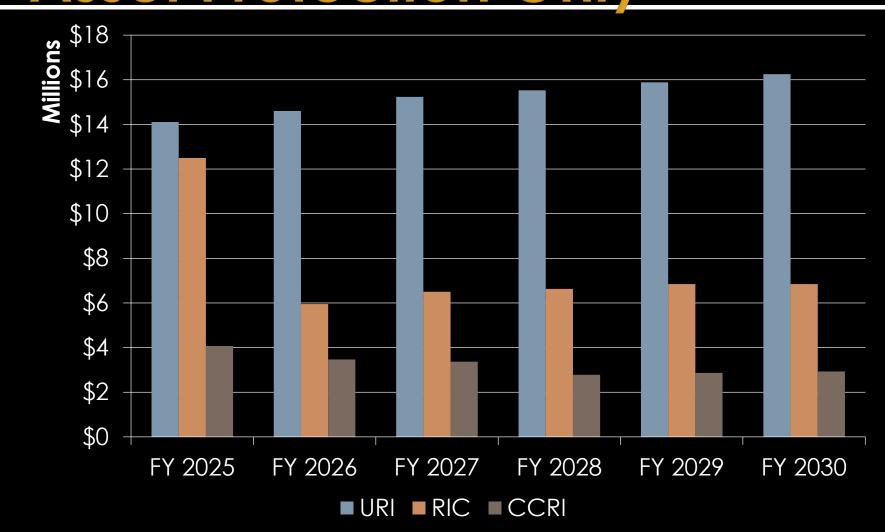

# Article 4 - Debt Management Act Joint Resolution

- Public Debt Management Act
  - Ensures that debt with a state tie was not issued without legislative review
    - Enacted in 1994
    - Subsequently amended to increase Assembly's approval role
  - Certain quasi-public agencies are exempt
    - Infrastructure Bank
    - RI Housing & Mortgage Finance Corporation
    - RI Health & Educational Building Corporation

- URI Combined Health & Counseling Center
  - 2019 Assembly authorized borrowing \$26.9M
    - Part of a \$32.9 million project
      - Included \$6.0 million from auxiliary balances
    - Construct new 49,000 sq. ft. centralized location for physical, mental, & emotional health
  - Approved at the same time as Memorial Union project
    - Plan was to proceed on both at the same time

- FY 2021 capital budget request delays 1-year
- FY 2022 delays another year
  - Related to COVID-19 emergency
  - Design also impacted by COVID
    - Smaller waiting areas
    - Need for additional isolation rooms
