Re: **Governor's FY 2026 , FY 2025 Revised and Capital Budgets**

On behalf of our network of member agencies and SOAR (Sisters Overcoming Abusive Relationships), our taskforce of survivors, the Rhode Island Coalition Against Domestic Violence (RICADV) appreciates this opportunity to support the proposed Judiciary budget in the Governor’s FY 2026 state budget.

We appreciate the Governor’s commitment to matching the resources appropriated to the RI Judiciary in FY25. Specifically, sustaining funding to the RICADV Domestic Abuse Court Advocacy program in collaboration with the RI Judiciary and District and Family Courts will help maintain life-saving victim services provided by the RICADV member agencies. **In the absence of this line-item, services offered by our advocates during pretrial appearances would be adversely impacted.**

The Domestic Abuse Court Advocacy Program provides direct assistance to victims of domestic violence or sexual violence with navigating district court cases and assistance with applying for civil restraining orders in Family Court or District Court as well. These life-saving services help survivors when the abuser has been arrested and when the victim needs a court protective order for themselves or their children, even without a criminal arrest. Advocates are available at every RI courthouse to provide support and empower survivors of intimate partner violence. The court advocate will explain the rights to the survivor, as a victim of a crime, and what to expect in the often-complex court process. The advocate can also help convey wishes to the prosecutors or other court personnel and help guide the survivor through the legal system.

The advocate will also make any referrals for the survivor for other vital resources through their domestic violence agency, and other local programs, such as counseling for adults and children who witness violence, legal services referrals, shelter and safe housing options, support groups, economic supports, crime victim compensation information, and more. All services are free and confidential for the survivor.

In 2024, 2,738 victims received support from a court advocate in obtaining a Restraining Order in District or Family Court. This statistic marks an increase from 2023, a change likely attributable to the line-item increase to the Court Advocacy program in FY25.

The RICADV is Rhode Island’s only recognized domestic violence coalition made up of agencies serving victims throughout the state. Our full-member agencies were among the first to provide services for victims of domestic violence in RI and have been the bedrock of our community’s response to domestic violence for almost half a century, providing essential services to thousands of survivors of domestic violence and their children every year. In 2024 alone, RICADV member agencies served 9,661 individual victims, provided 46,318 individual services, and answered 12,716 calls to the Victims of Crime Helpline and Agency Hotlines.

Thank you again for your continued investment in the Court Advocacy program. **As federal Victims of Crime Act funds wane, with further federal cuts predicted, state funding has never been more imperative to support the needs of survivors and end domestic violence in our state.**
