Dear Honorable Members of the RI House Judiciary Committee:

I'm writing to urge you to oppose passage of the so-called "Lila Manfield Sapinsley Compassionate Care Act" (2024-H7100). There are many reasons to oppose the legalization of assisted suicide, but ultimately, the reason I oppose it is because it is immoral. Life should be cherished and the suffering should be comforted, not abandoned in the name of compassion. And then there are the medical professionals who will be pressured to use their gifts to kill rather than heal and comfort. This is a nightmare we can easily avoid simply by saying no to this bill.

Other reasons for opposing this bill are found in two guest columns I published in the Providence Journal. The other guest column appeared in the print edition of the ProJo on Sunday, Feb. 26, 2023. I have attached a PDF of the column. The simplest way to avoid all of this is to refuse legalization of assisted suicide in any form.
