

RESOLUTION OF THE CITY COUNCIL

No. 181

Approved April 26, 2024

WHEREAS, House Bill 7373, introduced by Representatives Caldwell, Knight, Fellela, Batista, Boylan, Kazarian, Fogarty, Stewart, McEntee, and Handy on January 31, 2024, seeks to amend sections 11-47-60.1 and 11-47-60.3 of the General Laws in Chapter 11-47, Entitled "Weapons," focusing on the safe storage of firearms; and

WHEREAS, Senate Bill 2202, introduced by Senators Lauria, Pearson, Lawson, Gallo, Euer, DiMario, Miller, Felag, DiPalma, and Cano, on January 24, 2024, proposes amendments to Sections 11-47-60.1 and 11-47-60.3 of the General Laws in Chapter 11-47 entitled "Weapons,"; and

WHEREAS, House Bill 7373 and Senate Bill 2202 mandate that firearms must be stored securely in a locked container or equipped with a tamper-resistant mechanical lock or other safety device to prevent operation by unauthorized users, thereby enhancing the safety of Rhode Island homes and communities; and

WHEREAS, The bills introduce civil and criminal penalties for violations of safe storage requirements, establishing a framework for accountability and promoting responsible firearm ownership; and

WHEREAS, House Bill 7373 and Senate Bill 2202 extend the requirement of including a trigger lock or other safety device with the purchase of pistols, rifles, or shotguns, further ensuring the safety of firearms from unauthorized use; and

WHEREAS, The legislation requires firearms dealers to post informational signs regarding safe storage laws and the risks associated with improper firearm storage, thereby raising awareness and encouraging compliance; and

WHEREAS, House Bill 7373 and Senate Bill 2202 include provisions for the distribution of printed information on secure firearm storage and suicide prevention resources to firearms purchasers, as well as the development of educational materials for students and families on the importance of secure gun storage.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council hereby expresses its strong support for House Bill 7373 and Senate Bill 2202, recognizing these bills' critical role in promoting the safe storage of firearms, preventing accidents, and enhancing public safety across Rhode Island; and

BE IT FURTHER RESOLVED, That this resolution be transmitted to members of the Rhode Island State House of Representatives and the Rhode Island State Senate, and the Office of the Governor, to affirm the Providence City Council's endorsement of House Bill 7373 as well as Senate Bill 2202 and their comprehensive approach to firearm safety and community well-

being.

It is enacted by the General Assembly as follows:

4	(a) Nothing in this section shall be construed to reduce or limit any existing right t
5	purchase and own firearms and/or ammunition or to provide authority to any state or local agenc
6	to infringe upon the privacy of any family, home or business except by lawful warrant.
7	(b) A person who stores or leaves a firearm in any place is guilty of the violation of unsaf
8	storage of a firearm unless the firearm is secured in a locked container or equipped with a tamper
9	resistant mechanical lock or other safety device, properly engaged in order to render such firearn
0	inoperable by any person other than the owner or other lawfully authorized user. For purposes o
İ	this section, such firearm shall not be deemed stored or left if the firearm is being carried by or i
2	within such proximity to its owner or other lawfully authorized user that the firearm can be readily
3	retrieved and used as if carried on said person. Any violation of this subsection shall result in, fo
4	a first offense, a civil infraction punishable by a fine of not more than two hundred fifty dollar
5	(\$250), and for a second offense, a civil infraction punishable by a fine of not more than one
6	thousand dollurs (\$1,000). A third or subsequent violation of this subsection shall, upon conviction
7	be punished by imprisonment for no more than six (6) months, or a fine of not more than five
3	hundred dollars (\$500), or both,

14	SECTION 2. Chapter 11-47 of the General Laws entitled "Weapons" is hereby amended

16	11-47-60.4. Secure storage information and awareness.
17	(a) At any site where firearms sales or transfers are conducted by licensed dealers in Rhode
18	Island, the licensed dealers shall conspicuously display a sign containing the information set forth
19	in subsection (b) of this section, in any area where the sales or transfers occur. Such signs shall be
20	posted in a manner so that they can be easily viewed by persons to whom firearms are sold or
21	transferred, and shall not be removed, obscured, or rendered illegible. If the site where the sales or
22	transfers occur are the premises listed on the dealer's federal firearms license(s), an additional such
23	sign shall be placed at or near the entrance,
24	(b) Each informational sign shall be at least eight and one-half inches (8 1/3") high by eleven
25	inches (11") wide, and feature black text seainst a white background and letters that are at least
26	one-half inch (1/2") high. The signs shall not contain other statements or markings other than the
27	following text, in English and Spanish:
28	WARNING: Access to a firearm in the home significantly increases the risk of suicide,
29	death during domestic violence disputes, and the unintentional death of children, household
30	members, or others. If you or a loved one is experiencing distress and/or depression, call the 988
31	Suicide and Crisis hotline or text "HOME" to 741741,
32	Secure firearm storage is the law in Rhode Island, Rhode Island state law requires gun
33	owners to securely store their firearms any time the firearms are not in their possession or control
34	and to securely store finearms in premises under their control where a child or person probibled

from purchasing or possessing firearms is likely to gain access to them. Failure to securely store 2 firearms as required by law may result in fines and/or criminal prosecution. (c) The department of health, in consultation with the state police, shall develop detailed 3 printed information to be made available to licensed dealers at no cost to the dealers, in English and Spanish, regarding the risks of access to firearms, state laws requiring secure firearm storage, a summary of the major provisions of chapter 47 of title 11 relating to firearms, including, but not limited to, the duties of the sellers and purchasers and possessors of firearms, and suicide prevention resources. Licensed dealers shall distribute this printed information to all purchasers of firearms. (d). The department of health and department of education shall annually develop detailed 9 10 information for students and their families, parents and guardians regarding the importance of 11 secure gun storage to protect minors from accessing firearms, the risks of access to firearms, secure firearm storage requirements under state law, and suicide prevention and other behavioral health resources. School districts shall annually distribute a pamphlet containing this information, in English and in Spanish, to all enrolled students and their parents or guardians and make this information electronically accessible on the district's webpage. 15 SECTION 3. 12	within such proximity to its owner or other lawfully authorized user that the firearm can be readily
13	retrieved and used as if carried on said person. Any violation of this subsection shall result in, for
14	a first offense, a civil infraction punishable by a fine of not more than two hundred fifty dollars
15	(\$250), and for a second offense, a civil infraction punishable by a fine of not more than one
16	thousand dollars (\$1,000). A third or subsequent violation of this subsection shall upon conviction,
17	be punished by imprisonment for no more than six (6) months, or a fine of not more than five
18	hundred dollars (\$500), or both.
