Good afternoon,

I am writing this testimony in opposition to HB 5436, HB 5443, HB 5130, and HB 5069 and request that these bills be opposed by those who have taken an oath to uphold the Constitution of the United States. These bills, intended as direct challenges to the Second Amendment of our Constitution, have no place on the floor of the House to begin with.

These bills infringe on every Rhode Islander's Constitutional rights by punishing and criminalizing law-abiding citizens for lawful possession of firearms, and by making the process to obtain carry permits for self-defense and sport more difficult (in some cases impossible).
