I Briefly wish to express my viewpoint and opposition to Rhode Island Bill HB-5436. My reason is simple, This bill clearly is unfairly is trageting the law abiding Rhode Island (legal) gun owners, if this bill passes it impacts me personally, this would end my ability to train, to remain at top level family and personal security safety, this HB-5436 would close down the Shooting Ranges in Rhode Island, it would close down all licensed gunsmiths. It would cause all NRA Certified trainer's to lose there livihood, and cause dealers such as D&L Shooting Supplies in Warwick, RI severe econmic impact, with dealers, smiths, and supply store forced to be closed down.
