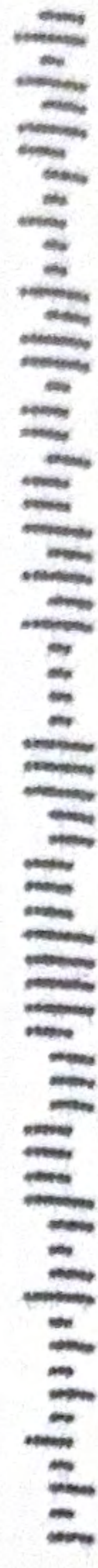

to trial" All my co-defendent's been home 2 to 3 year's ago (1) got probation  
another got 5 year's The other with 5 prior robberys got 3 year's and I got  
40 year's 20 year's with parole 20 without parole I would just like a  
chance to make it home to spend time with my mom and show  
her and myself I can make something of myself this sentence  
scare me straight you can say being release at the age of  
68 or so what oppournity's am I going to have with no  
support depending on the state to house me and  
everything else it's not a bright future just being honest  
I see it with the guy's that im locked up with lose love  
one 10 year is still a long sentence it's life changing  
for most we are alone hoping to reunite we love one's

when you lose them love ones your bitter i don't  
want that all i have is hope i don't want to lose  
that.
