

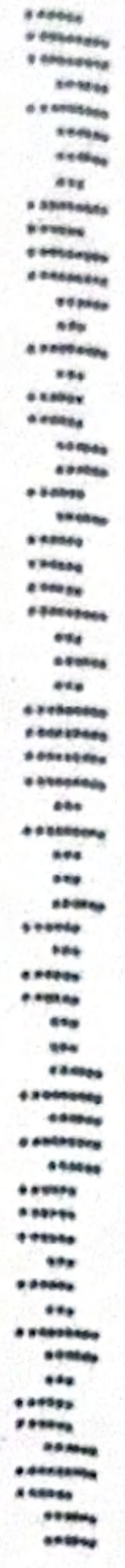

 for protecting my family from gang members
 who was bulling my family for years, they tried
 to make my daughter have sex with there leader

 and threw it in her face. They jumped both of my
 son's, put out a hit on my oldest son. they jumped
 on my granddaughters over a cell phone they thought
 she took from the leaders daughter, whom they were
 friends at one time. all this took place while I was
 living in Georgia, then I moved back here in 2009
 started my own busniss, doing clean up jobs, painting
 landscaping, ~~concrete~~ concrete pouring, etc. I was working
 three trucks. I did most of my work "RENT PRO" on
 368 Atwells ave Prov and "Rockingham INC" in Cranston
 plus all my private jobs from people seeing my work
 and asking for my "CARD" & number so they can call me
 to do what ever they wanted. Well any^{WAY} one day I
 got off work, I stop over by Chad Brown where
 my daughter Quandra lives, and just so happen to
 be a fight close to her house, so when I pulled^{UP} there,
 everybody said that's Quandra my daughter, she's fighting
 the gang leader and his baby mama which is

Tywaun Briggs and McKinley Irons Well anyway When I got to break up the fight with my daughter and Tywaun McKinley punched me in the face almost knocking me out because I was not expecting him to do that so I pulled out my rug cutter, that I use for work, because I just a surgery don't on my Right hand and couldn't use Well anyway he ran to his car grabbed his pistol, Knowing what I know about him I got in my truck and waited When I looked in my rearview mirror I saw him running toward me with two pistols, shot my tail light out, I know I should have called police but with my daughter living over and his gang mortality it would only have put not only me but my daughter life in danger, That's just how it is over there, so when I came back to check on my daughter as soon as he saw me he came running out flashing his guns, when he pulled them out I was ready with my pistol he shot and missed I shot back but I didn't miss. I got a lawyer the next day and was ready to turn myself in, but when my lawyer called the providence police station they said they didn't have a warrant for me yet, so I went back to work, 60 days go by then, finally they had to get a grand jury to indict me, I went to court

and my lawyer got me a bond hearing
 and I made first shot on bail my bond was
 \$150,000 The people I worked at Rockingham Inc.
 posted my bail, and I was on home confinement
 for two 1/2 years until my Trial started, Then I
 plea Bargain for 25 years and that's where I
 started at, so from 2017 to 2025 I've been
 in state custody I'm 67 years old I have
 not been in any trouble while in here I wrote
"Judge Kraus" to try and get my 2 1/2 years back
 that he took after I took the plea deal, I think
 he was upset because I picked the jury then I took
 the deal, but anyway he write back and said he
 will forward my information to the lawyer that I
 had in my case, which was "Judth Crowell",
 Judth called my wife may 2024 and her to tell me
 to stay out trouble and she is working to get me
 this second look law that the state was trying
 to pass for people like with 20 years or more
 and my age, so can you please contact my
 lawyer "Judth Crowell" and she will fill you in
