Dear Chairman Casey and Honorable Committee Members,

Any proposed legislation is assessed against these priorities to gauge its relevance and potential impact.

They convene frequently to discuss the merits of each legislative proposal, considering its implications and feasibility within the broader context of our organizational objectives.
- 4. Inclusion in Weekly Legislative Updates: Transparency and member input are paramount in our decision-making process. That's why we ensure that all members receive weekly updates on legislative developments, including the positions we are considering or taking. This provides an additional opportunity for members to weigh in and offer valuable insights.

5. Discussion at Monthly Board Meetings: Finally, proposed bills are brought to the table during our monthly board meetings. Here, they are subject to comprehensive discussions, allowing board members to deliberate and vote on whether to support or oppose them based on the insights gathered from previous stages of review.

By following this robust process, we strive to ensure that our organization's stance on legislative matters is well-informed, principled, and representative of the collective interests of our members.

The League agrees with the overall intent of this legislation as a benefit for cities and towns. There were, however, some thoughtful questions and ideas brought out through your committee process. We look forward to reviewing any additional updates that the sponsor feels might address that input in pursuit of making this bill even better.
