WHEREAS: Several municipalities are enabled to require registrations of business through state law; and

WHEREAS: Registration is beneficial to the Town and will assist the town in addressing zoning and taxation matters; and

WHEREAS: The Town respectfully requests that the General Assembly pass the attached proposed Bill.

NOW THEREFORE, BE IT RESOLVED BY THE CUMBERLAND TOWN COUNCIL OF CUMBERLAND, RHODE ISLAND AS FOLLOWS:
