Governor submits FY2026 state budget proposal

The FY 2026 state budget (2025-H 5076) proposed by Gov. Daniel McKee was introduced in the House by Finance Committee Chairman Marvin L. Abney (D-Dist. 73, Newport, Middletown). Over the next several months, the House and Senate finance committees will hold meetings to analyze the budget proposal.

General Assembly hears State of the State address

The Senate and House of Representatives met in grand committee Tuesday to hear Gov. Daniel McKee's State of the State address. Governor McKee spoke of plans to raise per-capita income in Rhode Island, a funding stream for the homelessness crisis, the replacement of the Washington Bridge and a proposed ban on assault weapons. Alzate and Murray plan to introduce 'millionaires' tax'

Rep. Karen Alzate (D-Dist. 60, Pawtucket, Central Falls) and Sen. Melissa Murray (D-Dist. 24, Woonsocket, North Smithfield) plan to introduce legislation that would create an additional Rhode Island personal income surtax on taxable income over \$1 million. The tax would help fund education, the rehabilitation of infrastructure and crucial programs that help the most vulnerable Rhode Islanders. Click here to see op-ed.

Rep. David A. Bennett (D-Dist. 20, Warwick, Cranston) has introduced legislation (2025-H 5029) to increase Rhode Island's minimum wage from \$15 to \$20 over a five-year period.

Cotter bill would cap electric and gas utilities' profits

Rep. Megan L. Cotter (D-Dist. 39, Exeter, Richmond, Hopkinton) has introduced legislation (2025-H 5018) to put a limit in state law on the profit that can be reaped by utilities distributing electricity and natural gas in Rhode Island. The legislation is intended to prevent utilities from making hefty profits at the expense of everyday Rhode Islanders who struggle under rapidly rising utility bills. Click here to see new release.
